BASIC & IMPORTANT RULES & REGULATIONS

To ensure each team is aware of the competition rules, regulations and conditions; team contacts are required to read all the information below.

Conduct:

PCNC encourages fair play. Never argue with an official. If you disagree, have your captain approach the official after the completion of the game.

Team Registration - R&R - Clause 4.2

Each team is required to register all its eligible players and pay the appropriate team and player registration fees prior to commencement of game 1 in the season proper. Failing which, a due date will be set, within the grace period of two weeks, for each Affiliated Company, Semi-Government Organization or NGO to register all its eligible players and pay the appropriate team and player registration fee.

Any Affiliated Company who intends to register an Affiliated Corporate Team must satisfy the following criteria to be eligible for registration and participation in the PCNC:

must have registered a minimum of 12 players in any one season: and must have registered a minimum of 8 female employees in any one season.

(c) The Human Resource Managers or General Managers attesting to the eligibility of the players must sign all registration forms.

ID Cards - R&R - Clause 5.1

Each eligible player must have a proper ID card. No photocopy is allowed.

ID cards must be presented to the Umpire prior to taking the court for each game.

Any violation of clause 5.1(a) and (b) must be.

noted on the score sheets.

team captains must be made aware of the violation; and the game will be forfeited.

Player Field Composition - R&R - Clause 5.2

to the opposing team. Each team is required to field the following eligible players to qualify for each game and for the finals:

four (4) or more permanent employees of an Affiliated Company, Semi-Government Organization or NGO; and

three (3) non-employees (female dependents or spouses).

Any team that fields more non-employees than employees of an Affiliated Company, Semi-Government Organization or NGO in any one game will be automatically forfeited and will lose their points.

More employees and less dependents. Female dependents cover Spouse (wife of an employee of the company) and Single natural/biological or legally adopted daughter aged between 13 -25 years.

Forfeit Fees

All teams must notify the PCNC Officials/Bench Committee as early as possible if your team has to forfeit.

Scoring Duties:

Each team must supply a competent official to sit next the official scorer during the game.

Failure to supply a competent scorer will result in the team having no right of complaint regarding the score.

Finals Eligibility-R&R-Clause 12.1 (b)

All players must play a total of four (4) games to qualify for all finals games. Please note: Byes do not count towards finals eligibility. There will not be any allowances towards this rule.

Any team that plays a player that has not qualified for finals will result in a forfeit.

To ensure player eligibility is confirmed – the team sheets must be filled in thoroughly each game (player signatures on scoresheet).

Uniform Rules - R&R-Clause 5.3 (a) & (b)

Players must wear a similar shade of colour top.

Closed in shoes must be worn by ALL players.

Facial piercings or a wedding band must be covered with brown tape; no other jewelry is permitted on court.

Tape or nail scissors will not be supplied by PCNC and is the responsibility of the team.

Behavioural technicalities-R&R-Clause 5.5 (a) (b) (c)

Any player, who causes harm to any other player, official or Executive with the intention of hurting the player, official or Executive will be removed from the game and suspended from participating in the competition for the remainder of the season.

Any player, who verbally abuses another player, official or Executive will be removed from the game and penalized in accordance with **clause 5.6**.

Appeals against any behavioral technicality must be forwarded to the Judiciary Committee for deliberation and decision.

Scoresheets - R&R-Clause 6.1 (a) (b) (c) (d) (e)

each team captain must ensure that only registered players are included in the score sheet and these players are physically present to take the court.

eligible players physically present and listed on the score sheet as a line-up and/or half time changes must be considered as having played and will be considered eligible to play in the finals.

changes made at half time or during the game must be clearly indicated on the score sheet next to the position played. The umpires and the opposing team's captain must be made aware of these changes. Both the umpire and the opposing team's captain must indicate on the score sheet in agreement with any changes.

reserve players must not be taken as having played a game unless their names are clearly indicated on the score sheet next to the position played in the first seven line up and/or half time changes; and

all necessary changes made to a score sheet must be signed by the official scorer, umpires and team captains.

Covid-19 Restrictions:

Sharing and swapping bibs is not permitted.

One spectator per player.

Players and spectators will need to sign in to assist with contact tracing. All players to sanitize hands before taking the court.

All players and teams will need to bring their own team equipment.
