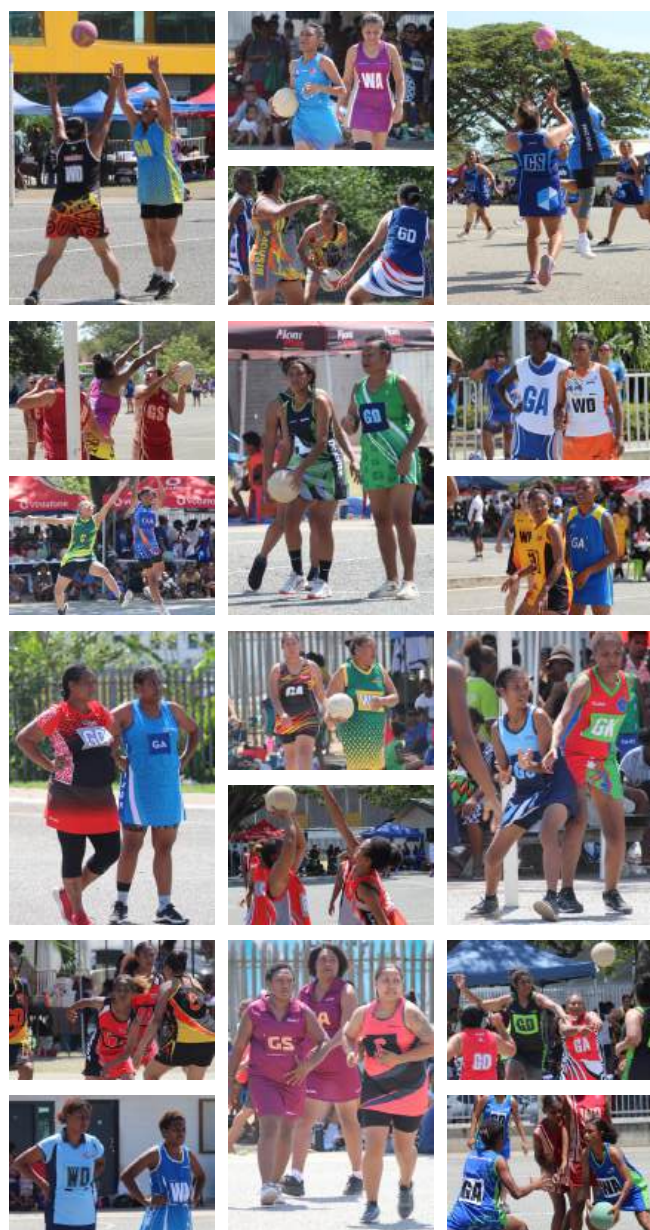
As we approach the second round, the executives are preparing for the grand finale and Awards Night.
